ANUNȚ
privind activitățile planificate de către EJTN în semestrul II al anului 2024

Potrivit Deciziei Comitetului Director din cadrul Rețelei Europene de Formare Judiciară (EJTN) din 8 iulie 2024 privind punerea în aplicare a bugetului prognozat pentru anul 2024, cu anumite excepții, majoritatea activităților planificate pentru toamna anului 2024 se vor desfășura în *format online*. Din păcate, unele activități urmează a fi anulate.

Această decizie a fost luată după o analiză atentă a execuției bugetare pentru anul 2024, susținând în același timp angajamentul EJTN de a oferi o paletă cuprinzătoare de activități de formare.

Cu toate acestea, anumite activități urmează a se desfășura în *format face-to-face, cu anumite condiții*. Acestea includ:

- Cea de-a 3-a ediție a Forumului Judges@Europe, cu mențiunea că a fost redus numărul participanților;
- Programul AIAKOS, cu mențiunea că a fost redusă perioada, numărul participanților, iar excepții nu vor mai fi remunerati;
- Marea Finală THEMIS;
- Programele de formare pe termen lung;
- *Vizitele de studiu* la Curtea de Justiție a Uniunii Europene-CJEU, la Parchetul European-EPPO și la Curtea Europeană a Drepturilor Omului - ECtHR, cu mențiunea că vizitele au fost reduse la 1,5 zile și că a fost redus numărul participanților (**a se vedea Anexa 3 din Decizia menționată**);
- *Programele de schimburi pentru autoritățile judiciare care au fost lansate sau pentru desfășurarea cărora au fost făcute rezervări*, urmând a fi propusă amânarea schimburilor bilaterale și individuale pentru care nu au fost făcute rezervări (**a se vedea Anexa 3 din Decizia menționată**).

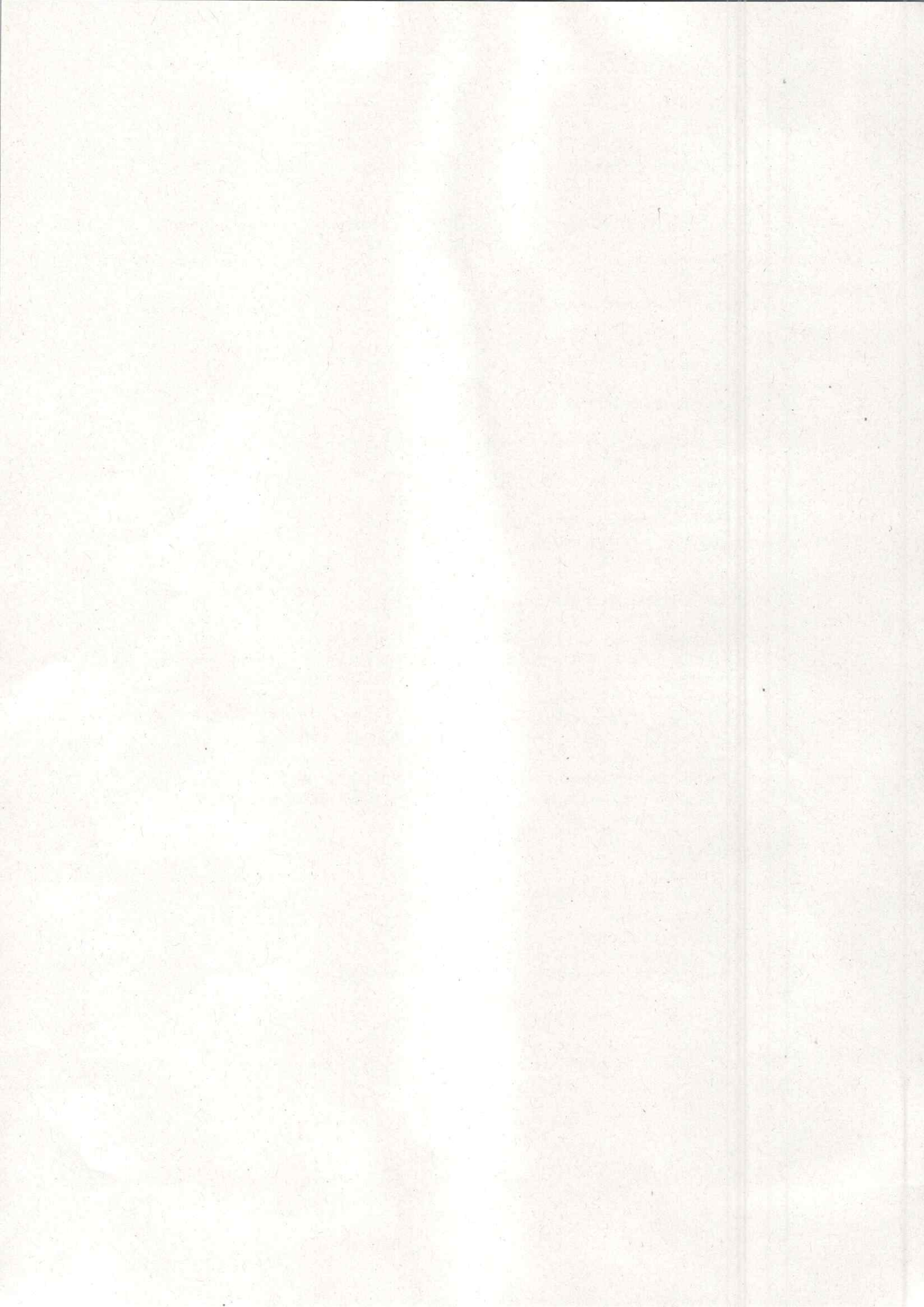
